Town Council Liaison:

COA Application – 312 W. Main Street

Tavi Wydicks stated that the application is to replace the existing wood decking on the primary structure and guest house with composite decking due to deterioration. Jim Renne stated that composite decking is a largely accepted material in historic districts.

Jeff Cox stated that the Commission approved the mural on the House of White building and this is less intrusive. Troy Wells stated that these types of murals are on trend in a lot of communities.

Jeff Cox who is the owner of the property stated that two of the columns were damaged in the tornado and wood is more expensive and harder to maintain than fiberglass is. Mr. Cox stated that there will be no change to the look, just the material.
