

Total Solar Eclipse

According to the Indiana Department of Homeland Security, a solar eclipse happens when the moon passes between the sun and Earth, casting a shadow on Earth that either fully or partially blocks the sun's light in some areas. This only happens occasionally, because the moon does not orbit in the exact same plane as the sun and Earth do, per NASA.



People located in the center of the moon's shadow when it hits Earth will experience a total eclipse. The sky will darken as if it were dawn or dusk. Weather permitting, people in the path of a total solar eclipse can see the sun's corona, the outer atmosphere which is usually obscured by the bright face of the sun.

WHEN WILL THE ECLIPSE OCCUR?



The eclipse in Newburgh will begin at approximately 12:46pm on April 8, 2024, and end at 3:20pm. During this time, the sun will be partially obscured by the moon, and you should use special eclipse sunglasses to view the eclipse without risking permanent eye damage.

The most special stage of the eclipse is called Totality. Totality is the maximum phase of a total eclipse which the moon's disk completely covers the sun.

Totality will start in the southwestern part of the state and will be over within just a few minutes. The exact duration depends on the location but should start in our area around 2:03pm and end around 2:05pm.

Total Eclipse - April 8th

On April 8th, between 2pm-4 pm, our region will experience more than likely a once in a lifetime viewing of a total solar eclipse. We are extremely lucky to have this in our backyard. The economic development and tourism opportunity has been equated to twelve Taylor Swift Concerts coming to the area. Crowd expectations are in the tens to hundreds of thousands regionally and in the millions all over the state. Preparations are being made by town and county officials for a surge of visitors to the area. Warrick County Schools will be closed that day and St. John's Catholic School will have a virtual learning day. State agencies are warning us that these three little minutes will stress our infrastructure for 3 days. Residents should limit travel during this time or expect very long delays due to heavy traffic. Officials warn extreme traffic congestion could last more than 12 hours after the event. You will want to make sure to have a few days' supply of fuel, food, and important medications on hand. Be prepared for communication disruptions due to heavy data usage. Restaurants and stores will be packed. Fuel shortages are likely, and emergency services will be saturat-

State agencies are also stressing the importance of eye safety and warn viewers there are many counterfeit eclipse glasses being sold. Only Eclipse glasses or solar filters should be worn to view the eclipse. Sunglasses, even very dark ones will not provide your eyes with sufficient protection. Eclipse glasses should be properly tested and shown to be safe. The American Astronomical Society is hosting a website with approved vendors that are selling eclipse products that have been vetted by the AAS Eclipse Task Force.

The Town is giving away free AAS approved Eclipse glasses to town residents while supplies last. Come into Town Hall during regular business hours with proof of residence to get up to 4 free pairs. Please only take what you need for your household to give as many people the opportunity as possible. Glasses will be available after March 29, 2024.



Except for the short period of totality, looking directly at the eclipse can cause permanent eye damage. The Indiana Health Department is recommending everyone keep their eclipse glasses/solar filters on during the entire event because knowing when those few seconds of totality occurs may prove difficult. The effect will not be lessened by filtered glasses so you are encouraged to err on the side of safety and just keep them on the entire time.

Upcoming projects: Playground at Lou Dennis Community Park



The Fortress of Fun playground at Lou Dennis Community Park is being replaced. This construction will allow us to prioritize safety while giving families a new playground that will serve children of all abilities, all ages,

and create new memories. The Newburgh Parks Board is committed to building an exceptional new space soon that will honor the Fortress of Fun's importance to our community members. If you would like to be involved in any way, please reach out to me. There will be open forums in the coming months to discuss selection of playground pieces and fund-raising events taking place so keep your eye out for information on these important dates. State Street Drainage Repair

The Town has identified an issue with an old storm drain running along State Street close to the State Street and Jennings Street intersection. This project will reroute a new storm pipe to correct



the issue and is anticipated to start early June and take approximately 10 weeks to finish. The stormwater improvements are fairly involved and will require two phases of road closures. Phase 1 will close the south portion of State St. from Jennings Street to Water Street. Phase 2 of the project will close the west portion of Water Street from State Street to the parking lot entrance. In addition, there will be directional changes on Water Street and Monroe Street to provide access to parking and properties in the immediate area. The parking lot along Water Street will be open for public use. We know this will be especially hard on the merchants and residents in this immediate area and want to make sure we are doing everything possible to minimize any negative impacts.

You can help by showing support to the merchants affected, keep your eye out for directional changes, and anticipate slight delays through this area while the project is taking place.



According to Indiana's Department of Homeland Security, the total solar eclipse will be highly publicized in the days leading up to April 8, 2024. Because of the rarity of a total solar eclipse, many thousands of people will be traveling to Indiana or from elsewhere within the state so that they can be in the path of totality. In fact, it is estimated Indiana may see as many as half a million out-of-state visitors for the eclipse, boosting the state's population by nearly 10%. This will lead to unusually high levels of traffic on roadways and crowds in Downtown Newburgh.

With the influx of people and traffic, Newburgh Town Council wants residents to consider the following the day of the eclipse:

- Expect possible increase in travel time, extreme traffic congestions, and large crowds along Water Street, French Island Trail, Old Lock and Dam Park and the Rivertown Trail.
- Expect considerable demand at gas stations and local stores. Consider doing errands the day before.
- If possible, do not schedule appointments for that day (e.g. hair appointments, doctor, dentist, etc.)
- Expect an increase in accidents and health and safety hazards, with response agencies possibly taking longer to respond.



Per NASA's website, except during the brief phase of a total eclipse, when the moon completely blocks the sun's bright face, it is not safe to look directly at the sun without specialized eye protection for solar viewing. Viewing any part of the bright Sun through a camera lens, binoculars, or a telescope without a special-purpose solar filter secured over the front of the optics will instantly cause severe eye injury.

When watching the partial phases of the solar eclipse directly with your eyes, which happens before and after totality, you must look through safe solar viewing glasses ("eclipse glasses") or a safe handheld solar viewer at all times. Eclipse glasses are NOT regular sunglasses; regular sunglasses, no matter how dark, are not safe for viewing the sun. Safe solar viewers are thousands of times darker


and ought to comply with the **ISO 12312-2** international standard. NASA does not approve any particular brand of solar viewers.

Important safety guidelines to follow during a total solar eclipse:

- View the Sun through eclipse glasses or a handheld solar viewer during the partial eclipse phases before and after totality. 2017 Eclipse glasses can be used as long as they meet ISO 12312-2 international standards and are not damaged in anyway.
- Always inspect your eclipse glasses or handheld viewer before use; if torn, scratched, or otherwise damaged, discard the device. Always supervise children using solar viewers.
- Do NOT use eclipse glasses or handheld viewers with cameras, binoculars, or telescopes. Those require different types of solar filters. When viewing the partial phases of the eclipse through cameras, binoculars, or telescopes equipped with proper solar filters, you do not need to wear eclipse glasses. (The solar filters do the same job as the eclipse glasses to protect your eyes.)
- You can view the eclipse directly without proper eye protection only when the Moon completely obscures the Sun's bright face during the brief and spectacular period known as totality. (You'll know it's safe when you can no longer see any part of the Sun through eclipse glasses or a solar viewer.)
- As soon as you see even a little bit of the bright Sun reappear after totality, immediately put your eclipse glasses back on or use a handheld

NEW EMERGENCY WARNING SIREN

Outdoor warning sirens generate sound through mechanical, electromechanical, or electronic means, and can produce audible signals ranging from tones of varying pitch, frequency, and duration. Outdoor warning sirens are used by public safety agencies to alert people about natural and man-made hazards.

The Town of Newburgh had two outdoor warning sirens that were installed between 1945-1950. The range on both sirens were no more than 2,400 feet and were both located on the east side of town. In 2023, Newburgh Town Council voted unanimously to remove the two existing sirens and install a new siren with a

5,400 foot range at Veterans Monument.

The Town of Newburgh worked with the Warrick County Emergency Management Agency (EMA) on the best location for the new siren. Veterans Monument is centrally located at the north end of Town up on a hill, which will allow the audible signal to reach as many residents as possible. The Town of Newburgh would like to thank the Warrick County Emergency Management Agency for their assistance during this project.

Mounts Electric will be removing the old sirens and installing the new siren. The Town of Newburgh and Mounts Electric have met with Centerpoint to find the best location at Veterans Monument that will service both the siren and the electricity needed to power it. No trees at Veterans Monument will be removed and the siren will sit back at the opposite end of the parcel, away from the monument itself.

The Town of Newburgh would like to also thank CenterPoint Energy for awarding the Town their Community Safety Grant in the amount of \$2,500 to go toward the Town's siren project. The remaining funds for the siren were paid for by the Town's Public Safety Local Income Tax.

The new siren, as were the old sirens, will be controlled via a radio by Warrick County Emergency Management Agency. The Warrick County EMA will be the agency to activate the siren during an emergency and in charge of

testing the siren. The Town of Newburgh will provide yearly maintenance of the siren.

The Newburgh Town Council takes the safety of their residents seriously and is proud to be installing this new emergency siren. If you have any questions about the emergency siren, please contact Andrea Balboni at abalboni@newburgh-in.gov.



Splash Pad Rules

- Use at your own risk

- No jumping off of benches or boulders
- No climbing on spray equipment
- No bikes, scooters, skateboards, skates or rollerblades
- · Pets, food, gum, glass objects, soaps are not permitted
- Tobacco usage is not permitted
- Water is chlorinated and recirculated through a filtration system—DO NOT DRINK
- Do not sit, stand, cover or block any water jets
- For your safety the splash pad is under video camera surveillance and is regularly monitored
- Splash Pad must be vacated at the first sign of thunder or lightning
- Patron refusing to obey posted rules are subject to removal from premises
- All other park rules apply

PLAYGROUND EQUIPMENT AND GROUND SURFACES CAN GET HOT

According to AccuWeather, air does not have to be hot in order for equipment and ground surfaces to heat up and cause burns. While metal equipment is typically thought of as a main threat, some plastics and rubbers as well as concrete have the potential to become hot enough to burn a child's skin.

The United States Consumer Product Safety Commission (CPSC) listed the following safety precautions to reduce your child's risk of burns:

- Always be aware of the sun and weather conditions
- Always check the temperature of the equipment and surface
- Remember that playground equipment, as well as playground surfacing, may cause burns
- · Remember, a young child's skin will burn faster than an adult's skin
- Always dress your children in appropriate clothing
- Always watch your children while on the playground



LOU DENNIS COMMUNITY PARK IMPROVEMENTS

Over the winter months, Lou Dennis Community Park received multiple improvements. This is the third year in a row that improvements have been made to the park. In 2021 the splash pad, community building, parking lot and basketball court were completed. In 2022, the Kiwanis of Historic Newburgh shelter house was built with financial assistance from Kiwanis of Historic Newburgh and multiple private donors. In the winter of 2023, the Town of Newburgh, with a grant from Warrick County, built a new shelter next to the Kiwanis Shelter, added electricity to both shelter houses, added a fence between the basketball court and the parking lot, made landscape upgrades, added a walking path between the parking lot and basketball court, and removed a 48-year-old shelter.

Lou Dennis Community Park will continue to receive upgrades over the years. A new Lou Dennis Community Park Master Plan was created in 2023 by Element Design and funded by Newburgh Park Pals, thanks in part from money raised by Kiwanis of Historic Newburgh during Walk of Dreams. The new design lays out the next phases of the park with a replacement to the twenty-five year old Fortress of Fun.

The park master plan has been approved by both the Newburgh Parks and Recreation Board and Newburgh Town Council. Newburgh Park Pals revealed the plan at their March 11, 2024 meeting. For a look at the plan, please visit Newburgh Park Pals website, Facebook page or Instagram.


SUPPORT NEWBURGH PARK PALS

FORTRESS OF FUN TO BE RAZED TO MAKE WAY FOR PARK IMPROVEMENTS

The Fortress of Fun was built with a community-wide effort 25 years ago that involved hundreds of volunteers, multiple sponsorships, and private donations. The Fortress of Fun has been maintained over the years by the Town of Newburgh and has seen countless repairs, replacement pieces, and painting projects that have allowed it to safely remain open past it's predicted 10-15 year life expectancy. The Newburgh Parks and Recreation Board recently had the Fortress of Fun assessed by the original company that helped build the playground, Leathers & Associates, as well as a Certified Playground Inspector. Both assessments concluded that the

structure should be closed and removed citing the deteriorating conditions. The Newburgh Parks and Recreation Board are currently seeking a third assessment from a structural engineer to allow the play structure to remain open through the summer.

Newburgh Park Pals, with the blessing of Newburgh Parks and Recreation Board, had a new Lou Dennis Community Park Master Plan created. The plan was paid for by Newburgh Park Pals and was created by Element Design. This ambitious redesign will add multiple amenities to the 11.66-acre park that will complement existing facilities and serve children with all abilities. Demolition will occur this fall, funding for the new playground is being procured, with site preparation and construction taking place once all funding is obtained. While removal of the Fortress of Fun may disappoint some residents, the Town of Newburgh is committed to the safety of its park users and continuing to enhance and grow Lou Dennis Community Park.

Below is the new Lou Dennis Community Park Master Plan that was created by Element Design. The design was released at Park Pals Annual Meeting on March 11, 2024 and a large print of the park can be found at Lou Dennis Community Park. This project is about preserving beloved memories while creating a new generation of positive experiences.

HOW TO COMPOST DRY LEAVES

To start, shred the leaves with a mower, and catch them in your mower bag.

- Add leaves to a compost bin.
- Laver the leaves with nitrogen-rich items like fresh grass clippings, food waste or manure.
- Build up the pile until its three feet tall and widealternating between layers of leaves and high-nitrogen product; keeping the volume equal.
- Turn compost once a month. Check for moisture. If you have dry spots—add water. If it smells or looks rotten dry it out using laves, straw or sawdust. The whole pile should have a similar moisture level to a damp but drained sponge.
- If you start with the right balance of materials and periodically turn the pile, you can have compost in a couple of months. The compost will eventually remain cool and become colonized by earthworms.

SPRING LEAF PICKUP

The Town of Newburgh is sponsoring a Town wide spring leaf pickup date. Households must register for the pickup. Renewable Resources will only pickup leaves from the households that register.

The spring leaf pickup date is scheduled for March 29, 2024.



Newburgh Neighbor Residential Grant Program

The Newburgh Neighbor Residential Grant Program is a matching grant program that assists property owners in restoring and rehabilitating homes within the Newburgh Historic Districts. Grants are limited to exterior preservation, restoration, or rehabilitation of homes.

Indiana Office of Community & Rural Affairs Historic Renovation Grant Program

Applicants with an eligible historic commercial structure have the opportunity to apply for project funding between \$5,000 and \$100,000 at a maximum request of 50 percent of the total eligible project cost. Eligible applicants include non-profits, individuals, partnerships, firms, associations, joint ventures, limited liability companies, corporation or non-profit affordable housing organization.

STORM DRAINS



In 2017, storm drain markers were placed on all storm drains in the Town. These markers are to make everyone aware that what you put down these storm drains ends up in our waterways and could pollute the Ohio River.

The markers are a federally mandated minimum control

measure that comply with MS4 requirements and enforced by IDEM (The Indiana Department of Environmental Management).

The storm drain markers are paid for by tax dollars and are property of the Town of Newburgh. They are not to be tampered with or illegally removed

SIGNS WITHIN PUBLIC RIGHT OF WAY



Pursuant to IC 9-21-4-6 and the Newburgh Code of Ordinances Section 157.196, private signs, including political signs are prohibited within the right of way. Please note that signs placed within

the public right of way may be removed by the Town staff without prior notice. Town personnel generally remove signs from the right of way as they are encountered in normal street maintenance activities. Removed signs will be taken to the Town Maintenance Facility located at the corner of First and Polk Street where they can be picked up.
